

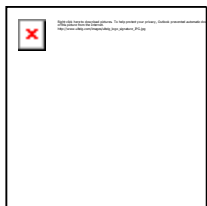

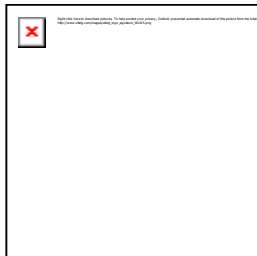

Not sure what your in house mapping capabilities are, but since our GIS specialist is overburdened with O&M projects **we see value in leveraging your team for this** and also the **value of you having direct access to the GIS/CAD files for respective designs.**

Let me know your thoughts on this and how may be best to proceed. Trying to find another way to increase transparency and bring value to the process.
